Managing the Complete Process

The preparation of performance returns can be a time consuming process. Data is not always available at the right time. In particular valuation data must be consistent with the financial transaction data submitted to IPD and there are additional issues to deal with:

- > Identification of relevant transactions which require specific performance treatments
- > The degree of detail required
- > The need to cope with late entries and change

Once the data has been collected it must be analysed for each Property, typically into the following categories:

- > Capital values for current and last periods
- > Acquisitions/Disposals/Capital expenditure and receipts in the period
- > Net Rent receivable

Transaction amounts often must be pro-rated manually by performance month in order to calculate accurate performance returns.


